PARTICIPANTS COVENANTS. In consideration for being permitted to enter for any purposes the Facilities for any reason, the Undersigned, for himself/herself and his/her personal representatives, heirs and next of kin, agents, assigns or anyone else who may pursue a cause of action on behalf of the Undersigned, acknowledges, agrees and represents that he/she has, or will immediately upon entering the Facilities, inspect such used for the intended purpose of entry and all portions thereof which he/she comes into contact; and further warrants that entry into the Facilities constitutes an acknowledgment that he/she has inspected the Facilities and accepts the same as reasonably safe and suited for the Undersigneds' intended purposes of entry as long as commercially/reasonably accepted. The undersigned further agrees and warrants that if at any time he/she is in the Facilities and he/she feels anything to be unsafe, he/she will immediately advise the proper officials and will leave the property used for the foregoing stated activities.

SECTION ONE: RELEASE AND COVENANT NOT TO SUE. The Undersigned hereby releases, waives, discharges and covenants not to sue the Released Parties from all liability to the undersigned and the undersigned's personal representatives, assigns, heirs and next of kin, for any and all loss or damage and any claim or demands therefore on account of injury to the person or property of the undersigned or resulting in death of the undersigned, whether caused by the negligence of the Undersigned or other participant in any activity being conducted at the Facilities or otherwise, while the Undersigned is in the Facilities for any purpose participating and/or observing any activities. This Release does not prevent the Undersigned from collecting medical payments from the Church's medical payments provision of its insurance policy if injured while at the Facilities.

SECTION TWO: INDEMNIFICATION. Further, the Undersigned agrees to indemnify and hold forever harmless the Released Parties against and from any action, causes of action, claims, demands, judgments, executions, costs, expenses, attorney fees and any and all claims or damages whatsoever, that may be instituted against or recovered from them as a result of the Undersigned utilizing and/or participating in any way at the Facilities. This Section does not prevent the Undersigned from collecting medical payments from the Church's medical payments provision of its insurance policy if injured while at the Facilities and does not require Undersigned to Indemnify the Church for payments made under the Church's medical payments portion of its insurance policy.

SECTION THREE: ASSUMPTION OF RISK. The Undersigned hereby assumes all risk of bodily injury, death or property damage due to the use of the Facilities, or otherwise, while in or at the Facilities for any activity.

SECTION FOUR: SCOPE OF RELEASE AND INDEMNITY. The Undersigned expressly agrees that the activities conducted at the Facilities can be very dangerous and involve the risk of serious injury and/or property damage. The Undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of Indiana and that if any portion of it is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

SECTION FIVE: SCOPE OF RELEASE AND INDEMNITY. I hereby grant the Church permission to use my likeness in a photograph, video, audio recording or any other form of media for any and all publications, including Web site entries, without payment or any other consideration. I understand and agree that these materials will become the property of the Church and will not be returned. I hereby irrevocably authorize the Church to edit, alter, copy, exhibit, publish or distribute the media for purposes of publicizing the Church's programs or for any other lawful purpose. In addition, I waive the right to inspect or approve the finished product, including written or electronic copy, wherein my likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of the media. I hereby hold harmless and release the Church from all claims, acting on my behalf or on behalf of my estate have or may have by reason of this authorization.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
